Otherwise, the participant has to settle all fees in cash or by credit card (Visa or MasterCard) on-site the conference in Dresden. All bank charges will be for the account of the participant.

For cancellations received up to and including the 16th March 2026, a handling fee of 100,00 € plus 19% VAT will be charged. The remaining amount will be refunded after the conference. For cancellations after this date, no refunds will be applicable. We point to it that in this case the obligation continues to the payment of the registration fee. Cancellations and any changes must be made in writing to CMD. The conference documents will be sent to you after the conference.

CMD acts as an agent only and accepts no liability, injury or the destruction of or damage to property regardless of the cause thereof. Attendees participate in all events at their own risk.

Hotel reservation - Accommodation tax
